The right of rescission DOES NOT apply to the following a loan to purchase or build the consumer's principal dwelling. The right of rescission also DOES NOT apply to a refinancing or consolidation by the same creditor (however, in these situations, if cash is taken out, the right of rescission applies to the "cash out" portion of the loan).
